- Design committee is exploring new infrastructure projects for 2023, Funding will come from remaining balance from Heart of the Harbor project, solicit additional \$'s to support.
- PWMS is assisting the Ewigs fill ZuZu Pedals spaces in the Boerner Building.
- PWMS will advocate for continuing financial support from the City of PW, will request \$15K in additional funding each year. City of PW is going through budgeting for 2023, PWMS should know by mid-Sept whether city of PW will provide any additional – direct funding.

Main Street Funding Request

Funding request submitted by Port Washington Main Street executive director for \$16,500 for 2022 third quarter. In accordance with the Special Funding request granted to PWMS for \$9,000 (request for 2022 only – made during the May 2022 meeting) to pay for administrative assistant, PWMS requested \$3,000, one-third of that request for the third quarter funding.

Motion made by Brian Barber to approve both the standard PWMS funding request of \$16,500 and special funding of request of \$3,000 for 3rd quarter 2022. Seconded by Laura Burke. All in favor – motion passed.
