## **MINUTES**

- 1. ROLL CALL- Mayor Ted Neitzke IV convened the meeting of the Common Council at 6:30 p.m. Members present were Alderpersons Deborah Postl, Paul Neumyer, Mike Gasper, Jonathan Pleitner, Patrick Tearney (present by telephone), and John Sigwart. Members absent and excused were Alderperson Dan Benning. Also present was Interim City Administrator/City Clerk Susan Westerbeke, City Attorney Eric Eberhardt, ADA/HR Director Emily Blakeslee, Public Works Director Rob Vanden Noven, and Director of Planning and Development Bob Harris.

Ordinance 2024-2: Amending and/or Creating Zoning Ordinances to Allow and Regulate Recoding Studios as a Conditional Use in the I-1 Existing Industrial District-1<sup>st</sup> Reading- Director of Planning and Development Bob Harris was present to review the Ordinance to amend the City of Port Washington Zoning Code to add "Recording Studios" as a conditional use in the I-1 industrial district. This Ordinance change is under review with the Plan Commission. This Ordinance will be considered at the next Common Council meeting.
