Absentee Ballot Information

- Applications to receive ballots by mail for the November 5th General Election can be submitted now through November 1st.
- Applications can be submitted through MyVote.wi.gov -or- by mailing in an Absentee Ballot Application to the City Clerk, 100 W. Grand Ave. The Absentee Ballot Application can be obtained and printed from the City's website at https://www.portwashingtonwi.gov/departments/city-clerk/elections/absenteeearly-voting.
- Note: Photo ID is required to receive an absentee ballot.

Voter Registration

- Beginning October 24th the late registration period begins and voters must complete voter registration In Person at the City Clerk's Office.
- Voter Registration may also be completed on Election Day at your Polling Location prior to Voting.
- Voter registrations must include a Proof of Residency document such as WI Driver's License/WI ID, Utility Bill, Bank Statement/Credit Card Statement, Payroll Document, Real Estate Tax Bill, Document from a Unit of Government. There are additional approved document options which can be found on the City's website at https://www.portwashingtonwi.gov/departments/city-clerk/elections/voter-registration.
- Note: There is a 28-day residency requirement prior to election day to be able to submit a Voter Registration Application.



In Person Early Voting By Absentee Ballot will be available for the November 5, 2024 General Election *at City Hall, 100 W. Grand Ave* during the dates and times listed below. Please have an *acceptable Photo ID available* (see Wisconsin Elections Commission information for acceptable Photo ID below). For complete Elections information, please refer to page two of this newsletter or the <u>Elections Page</u> on the city website.



Tuesday - Friday - October 22 - October 25 - 8:00am - 4:00pm Monday - Thursday - October 28 - 31 - 8:00am - 4:00pm Friday - November 1* - 8:00am - 5:00pm (*Only City Clerk's Office at City Hall is until 5:00pm.)

These Photo ID's are acceptable for voting purposes:

- Wisconsin DOT-issued Driver's License (even if driving privileges are revoked/suspended)
- Wisconsin DOT-issued Identification Card
- Military ID card issued by U.S. Uniformed Services
- U.S. Passport book or card

These Photo ID's are also acceptable for voting purposes:

- Certificate of naturalization (that was issued not earlier than two years before the date of the election)
- ID card issued by a federally recognized Indian tribe in Wisconsin
- Driver's License receipt issued by Wisconsin DOT (valid for 45 days from issuance)
- Identification Card receipt issued by Wisconsin DOT (valid for 45 days from issuance)
- Wisconsin DMV ID Petition Process Photo receipt (valid for 60 days from issuance)
- Veterans Affairs ID Card (must be unexpired or have no expiration date)
- Photo ID Card issued by a Wisconsin accredited university or college, or technical college containing the following: Date card issued, signature of student, expiration date no later than two years after date of issuance, if expired must be accompanied by a separate document that proves current enrollment (tuition fee receipt, enrollment verification letter, or class schedule)



RESPECT OUR WATERS

Help keep our waterways safe by keeping an eye out for dangerous dumping, known as *illicit discharge*. This involves **anv substance other than stormwater** that enters the storm drain, storm sewer, or local waterway. Examples of illicit discharge include:

- Sanitary wastewater
- Effluent from septic tanks
- Spills from roadway accidents
- Improper disposal of auto and household hazardous wastes

These substances lead to nutrient, bacteria, and chemical pollution in our freshwater systems.

Contact the Department of Public Works, 262-284-2600, immediately if any of the following are noticed:

- Storm drain or pipe leading to a waterway that has:
 - An unusual odor
 - Suds
 - An oil sheen
 - Flowing water during dry weather

Marina Breakwater **Improvement Project**

In August, the Department of Public Works received an update on the proposed U.S. Army Corp of Engineers Breakwater Improvement Project. Armor stone will be placed along the breakwater (see photo on the left). This will reduce wave energy, increase protection to the gateway, specifically the railing, which is highly susceptible to damage in the winter. These improvements will help extend the life of the breakwater. Roen Salvage of Sturgeon Bay is scheduled to begin work on the north breakwater during the week of September 9. The breakwater and access to the light station will be closed to pedestrians during this time. This schedule may change due to weather and other factors. Information will be posted on the city website and social media as it becomes available.

FIRE PITS & OUTDOOR FIREPLACES

Ch. 224-32 of the Municipal Code outlines Ordinances related to fire pits and outdoor fireplaces.



Below-ground fire pits have specific size, location & materials requirements, 25 ft. from any structures or combustible materials.



Locate portable firepits/fireplaces a minimum of 15 ft. from any structures or combustible materials.



Fire must be constantly attended & supervised until completely extinguished. Portable fire extinguisher or garden hose must be present.



Only natural firewood or commercial fire logs may be burned. Burning of all other materials are prohibited.
