- 2. Approve Minutes of Previous Meeting Motion made by Ald. Postl, seconded by Ald. Benning to approve the minutes of the previous meeting as presented. <u>Motion carried unanimously</u>.
- Approve Annual Cabaret License for the July 1, 2021 June 30, 2022, License Year for Tello's Café and Catering, 200 W. Grand Avenue. The City Clerk has reviewed and approved the application and finds it complete. All required fees have been paid. Motion made by Ald. Postl, seconded by Ald. Benning to recommend approval of the Annual Cabaret License for the July 1, 2021 June 30, 2022 License Year for Tello's Café and Catering, 200 W. Grand Avenue as presented. Consideration and Possible Action on Resolution 2021-21 Approving a Simplified Rate Increase for the Port Washington Water Utility with Implementation Beginning on the Bills Issued January 31, 2022 Resolution 2021-21 would implement a 3.0% simplified rate increase for Water Utility beginning on the bills issued January 31, 2022. This increase will get the Water Utility closer to the Public Service Commission's recommended managing benchmark rate of return of 5.0%. This Simplified Rate Case is an inflationary type of increase that helps the Utility maintain rate continuity and provides additional capacity to assist Staff as they continue to plan for the Water Filtration Plant Maintenance Project. Motion made by Ald. Benning, seconded by Ald. PostI to recommend approval of Resolution 2021-21 Approving a Simplified Rate Increase for the Port Washington Water Utility, with Implementation Beginning on the Bills Issued January 31, 2022, as presented. Motion carried unanimously.
